- A. Call Selectboard Meeting to order and Pledge of Allegiance
1. Chair Whitney Cunliffe called the meeting to order at 5:30.
 2. Town Manager's Report: Nick reported that the Highway Department successfully managed the recent snowstorm, working long hours with no reported accidents and receiving numerous compliments from residents for their attentiveness and road conditions. He also recognized the Parks and Recreation Department for quickly opening and staffing an emergency warming shelter during the recent period of sub-zero temperatures. Although overnight sheltering was ultimately not required, staff ensured the facility was prepared and available to residents in need on short notice. Nick provided an overview of upcoming changes to the municipal budget process. He explained that, rather than holding a single day-long budget meeting, departmental budget presentations will be spread across multiple Select Board meetings between late February and March. This approach is intended to improve public transparency, reduce meeting fatigue, and allow department heads adequate time to explain their budgets and answer questions.
 3. Department and Committee Reports:
Police Department – Chief Bucknam: Reported on a recent joint training exercise conducted with the National Guard at the Armory, which included coordination between the Police Department and Fire Department. He stated that the exercise went extremely well and was valuable in preparing for critical incident response. As a result of its success, there has been discussion about conducting similar joint trainings in the near future to maintain readiness and identify areas where additional staffing or procedural adjustments may be beneficial. Chief Bucknam also addressed winter road safety concerns, noting that while roads are regularly



plowed, changing temperatures can create wet conditions and black ice, particularly on Madison Avenue. He urged motorists to use caution, reduce speed, allow additional stopping distance, and remain alert for turning vehicles and pedestrians. He emphasized the importance of due care to prevent accidents and thanked residents for limiting unnecessary travel during recent weather events.

Highway Department – Jason Finley: Reported that the Highway Department responded effectively to recent winter weather events, with crews working extended hours to keep roads clear and safe. He noted that overall road conditions have been well received by residents, with positive feedback shared with the department. Jason also addressed current concerns on Madison Avenue, explaining that temporary conditions remain until final paving and top coating can be completed in the spring or summer. In the meantime, motorists were encouraged to use caution, particularly when navigating intersections, side roads, and driveway entrances affected by elevation differences.

Town Clerk – Gail Pelotte: Reminded residents that dog registrations are due by the end of the week. She noted that the Town is operating under a new system and is no longer able to make courtesy reminder calls. Any registrations completed after the close of business on Friday will be subject to a \$25 late fee per dog beginning Monday. Residents were encouraged to complete registrations before the deadline to avoid penalties.

4. Conflict of Interest Disclosure: None declared by Selectboard Members.
5. Selectboard Items: Amber thanked residents and local businesses for attending the Augusta trade show She also highlighted that Build Maine will return to Skowhegan on June 2–3, a conference for town planners, managers, architects, and others involved in town development, and encouraged town officials to attend. Ethan praised the public works team, especially Jason, for excellent road maintenance during a recent storm. Whitney addressed road conditions on Madison Avenue, noting that until the topcoat is applied, some side roads and driveways are higher than the street, making it difficult for residents to enter or exit safely. Drivers were urged to slow down and be patient.
